RULES

1. Show is limited to residents of Inyo, Mono and Alpine Counties, and those areas of Nevada including: Smith Valley, Gardnerville, Minden, Sweetwater Valley, Tonopah, Fish Lake Valley, Hawthorne, Smokey Valley and Schurz.
2. Exhibitors who are members of 4-H or FFA must have been enrolled in the project 60 days (120 days for Beef & Horses), must have project records and proof of supervision. Independent exhibitors must provide the Livestock Office with a photo of their animal, proof of ownership, ear tag, tattoo or notch, and project records with entry forms. Independent exhibitors will be placed in shows with 4-H or FFA.
3. Exhibitors may show two(2) market animals per species, but may only auction one(1) large (beef, sheep or swine) and one(1) small (rabbit or turkey).
4. All animals must be fit and ready for show upon arrival at the fairgrounds. No electric clippers are permitted on the grounds.
5. Exhibitors will be assigned pens by the livestock office. Market beef will be given pens and a tie area. Exhibitors may not change pens without permission of the Livestock Superintendent.
6. All small livestock must be on grounds before 5:00 pm, Tuesday, July 13th, 2010.
7. Turkeys will be weighed in on Tuesday, July 13th, 2010 at 7:00 pm. Exhibitors, or their representative, must be available when turkeys are weighed.
8. All large livestock must be on grounds before 5:00 pm on Wednesday, July 14th, 2010.
9. Beef will be weighed Wednesday, July 14th, 2010 at 4:00 pm.
10. Sheep & Swine will be weighed Wednesday, July 14th, 2010 at 5:00 pm
11. Animals may only be weighed once. Exhibitors or leaders may ask for a re-weigh, providing the animal has not left the scale area. Only one re-weigh is allowed.
12. Any attempt to alter the weight of an animal by artificial means is cause for disqualification, and removal of the animal from the fairgrounds.
13. Exhibitors who are unable to be at weigh-in may have another exhibitor or sibling weigh their animals for them.
14. **Beef exhibitors must have a brand inspection and transportation slip at weigh-in.**
15. Lambs must be dry and blankets removed before entering the scale area for weigh-in.
16. **To qualify for exhibit, market lambs must be docked such that the tail (dock) is healed and can be lifted from the exterior. Lambs that have no dock will not be eligible (State Rule IX:A).**
17. Any animal showing evidence of disease or fungus of any kind will be subject to possible removal from the fairgrounds per vet check.
18. **Each exhibitor is responsible for preparation and care of his/her own animal, adult help is not permitted.**
19. 4-H and FFA members must have their leader or advisor signature on entry forms. Independent Exhibitors must have parent or guardian signature. Entry forms without signature will not be accepted.
20. Exhibitors must show and sell their own animals.
21. **SUBSTITUTE ANIMAL HANDLER:** In the event of a scheduling conflict due to a prestigious youth activity or important family activity, an exhibitor may make written request for a substitute handler. This request must be made seven(7) days prior to the show. Letter must explain why the exhibitor will be unable to show his/her animal. Letter must include name of substitute handler and must be signed by exhibitor, exhibitor's parents, leader or advisor and the substitute handler. Each request will be reviewed by the Board of Directors of the 18th District Agricultural Association and the exhibitor will be notified if request is approved.
22. **UNIFORMS:** All FFA and 4-H members must wear the official uniform of their respective organization:
FFA: Black pants, white long sleeved tailored shirt, FFA jacket and tie; no hat.
4-H: Dark navy blue pants (jeans or cords), white long sleeved tailored shirt, 4-H tie or scarf and 4-H hat.
INDEPENDENT EXHIBITOR: Dark blue or navy pants, white long sleeved tailored shirt; no hat.
23. Exhibitor Age for eligibility is as of January 1, 2010.
24. **Exhibitors under the age of 18 must be accompanied by a responsible adult. Drinking and possession of drugs or alcohol will be cause for dismissal from the fair grounds and the exhibitor will not be permitted to take their animal through the auction.**
25. **Curfew in the barns and camping area is 10:00 pm.**
26. Fair management reserves the right to order the removal of any entry that is not in the best interest of the fair, endangers the public or staff by being allowed to be shown. All large livestock must be broke to lead and manageable by the exhibitor.
27. County, District and State Fairs cannot legally carry liability insurance covering the exhibitor and/or their entries. Liability insurance is the responsibility and the discretion of the exhibitor.
28. Any deviation from the rules printed in this Exhibit Guidebook will be grounds for disqualification.
29. All California Fairs are governed by the California Department of Agriculture, Fairs and Expositions State Rules. Copies of the California State Rules are available from the Livestock Office and on line at www.cdffa.ca.gov. Violation of State Rules will result in automatic disqualification from showing and can mean an exhibitor may be barred from showing in any California Fair.
30. **ANIMALS ARE NOT PERMITTED TO LEAVE THE GROUNDS UNTIL THE RELEASE DATE AND TIME OF SUNDAY, JULY 18th @ 9:00AM. NO EXCEPTIONS**
31. **ALL ANIMALS MUST HAVE CONSTANT ACCESS TO WATER!**

2010 AUCTION RULES

1. Only one (1) large animal (beef, sheep & swine) and one (1) small animal (rabbit meat pen, turkey) per exhibitor may be sold at the Junior Livestock Auction.
2. All champions of each market species must be sold. No exceptions.
3. All other market animals eligible for auction will be sold unless the Livestock Office is notified by Friday, July 16th, 2010 by 8:00 pm. Once the Auction Catalog has been printed no animal may be removed from the auction.
4. Exhibitors who show more than one(1) market animal must report to the Livestock Office by 8:00 pm Friday, July 16th, 2010 to tell the office which animal they plan on selling. If the Livestock Office is not notified by 9:00 am, the highest placing animal will be put in the auction and must be sold.
5. Maximum pay weights (beef, 1300 pounds; sheep, 135 pounds; swine, 265 pounds) are relevant solely to the Junior Livestock Auction and will not be considered in the class break process. Appropriate weight ranges for class winners will be determined by the individual judges and their interpretation of current market standards.
6. Only those animals that have been entered and shown in the Eastern Sierra Tri-County Junior Livestock Show are eligible for processing at Lahontan Valley Meats. In addition to the standard processing fees, there will be a \$30 per head transportation fee for animals that were shown but not auctioned.
7. Sale Order: beef, hogs, lambs, rabbit meat pens, turkeys.
8. Only rabbit meat pens determined to be market ready by the judge will be sold at auction. Grand Champion and Reserve Grand Champion Rabbit Meat Pens must sell.
9. Only Group 1 Turkeys may sell. Grand Champion and Reserve Grand Champion Turkeys must sell.
10. Auction animals declared to be unfit at the time of processing because of illness, unethical substances or an illegal act or substance, are the responsibility of the seller. Any other cases will be subject to review by the Junior Livestock Auction Committee. Any replacement will be of like kind.
11. Exhibitors will be charged commission in the amounts of \$35.00 for large animals (beef, sheep, swine) and \$25.00 for small animals (rabbit meat pens, turkeys) to help defray the auction costs.
12. Auction checks will be available two weeks following the auction. 4-H members may pick up their checks from the 4-H Office and must bring an addressed thank you note to buyer(s) with stamp attached and completed record book. BUHS FFA members may pick up checks at the High School District Office and must bring an addressed thank you note to buyer(s) with stamp attached. Auction checks for independent exhibitors and those from Nevada will be mailed.
13. All auction checks must be cashed within 90 days of issue.

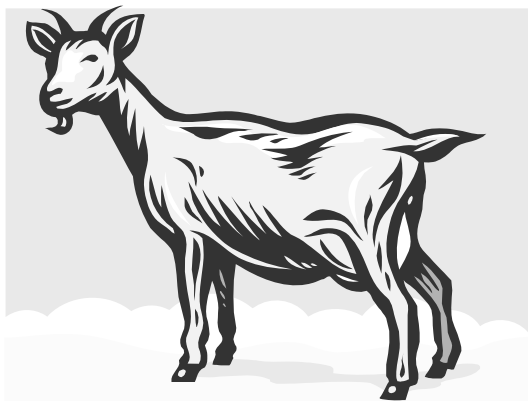

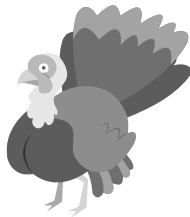
