## FAMILY WRIST BAND INFORMATION

The Eastern Sierra Tri County Fair will be requiring all persons to have a wrist band for admittance on to the fair grounds. Every child entered will receive a free admittance wrist band into the fair. If a family has one child entered they will receive one free adult wrist band. Families with 2 or more children entered will receive a maximum of 2 free adult wrist bands. **Adults who receive wrist bands must have a liability waiver on file.**

Wrist bands will be distributed when entries and payment are received.

All additional family members who are not competing in the Open Rodeo at 7:00pm will be required to purchase a gate ticket. Presale tickets may be purchased via the Eastern Sierra Tri County Fair website or may be purchased through the fair office when parents sign up their children for the rodeo. After purchase, tickets will be available for pick up on will-call.
