COMMERCIAL VENDOR APPLICATION INFORMATION

Thank you for your interest in being a commercial vendor at the Tri-County Fair.

The 2026 Tri-County Fair will be held September 3-6, 2026.

Thursday & Friday = 4 PM to 12 AM

Saturday & Sunday = 12 PM to 12 AM

THINGS TO KNOW:

- **Indoor booth fees** = \$450 per 10' x 10' location for the duration of the fair.
- **Outdoor booth fees** = \$500 per 10' x 10' location for the duration of the fair.
- Indoor and Outdoor Commercial booth fees include 8 – 1-day gate passes and 1 – 4-day parking.
- Additional vendor admission passes are available at the reduced rate of \$3 per person per day (plus fees unless paying via cash) and 4-day vendor parking passes are available for \$15 for the duration of the fair. Single-day parking is available at \$5 per vehicle, per day (no return privileges).
 - Vendors are required to park in designated areas.
- **BOOTHS MUST BE staffed for the following hours for the optimum selling advantage:**
 - Indoor Booths: Thursday & Friday 4 PM to 11 PM / Saturday & Sunday 12 PM to 11 PM
 - *The indoor building is locked every night and unlocked in the am with supervision.*
 - Outdoor Booths: Thursday & Sunday 4 PM to 11 PM / Friday & Saturday 12 PM to 12 AM
- *Tents, tables, and chairs are the responsibility of the applicant. Equipment is not provided.*
- **All tents must be inherently fire resistive or treated and labeled accordingly.**
- Any food items (pre-packaged, freeze-dried items, candy, etc.) must comply with Inyo County Health Department requirements; health permit fee and application required.
- **ALL VENDORS MUST PROVIDE INSURANCE** – A minimum of \$1,000,000 general liability per occurrence, naming the Tri-County Fair as additional insured.
 - If a Vendor cannot provide their own insurance, coverage may be purchased through California Fairs Services Authority (CFSA), which the Fair Office Staff can assist with.
- Electricity, 10 amps/1200 watts, is available for each booth. If you have excessive electrical needs, please contact the Fair Office prior to submission of this Application.
 - Additional electrical fees may apply.
- RV parking spaces are limited, so please specify on the application if one is needed. **No guarantee of space or of any hookups.**

If accepted, you will be contacted via email to confirm availability and then a contract will be issued.
