YOUTH POSTER CONTEST

“Summer Tans & Cattle Brands”

The 4th annual Tri-County Fair Youth Poster Contest is under way for Inyo, Mono and Alpine County youth in grades 5th–12th.

NEW We have created two categories (1) Hand Drawn Art (2) Computer/Digital Art to engage more youth artists! We will select TWO winners this year, one in each category!

This is a great opportunity for you to use your imagination and begin to enjoy the fun of the Fair early in the year. If you like to draw, paint, collage or do some other type of two-dimensional artwork this is for you! If you have a child or student who is artistically gifted, encourage them to work on a poster image. Each child who enters will receive (2) Fair admission tickets. All artwork submissions will be displayed during the 2023 Tri-County Fair. The winning poster will be used as the Official Poster of the 2023 Tri-County Fair. Cash awards and (2) unlimited ride wristbands will be awarded to the top 3 finalists: 1st Place \$500, 2nd Place \$250, 3rd Place \$100 **It's fun! It's easy and it's a gift to the community.**

Check these rules carefully, and have fun with your artwork!

Deadline for submissions is Monday, April 3, 2023.

The theme for the 2023 Tri-County Fair is **“Summer Tans & Cattle Brands”**. Winning posters will artistically and colorfully communicate this theme and promote the Tri-County Fair. Entries must be original two-dimensional works of art created by the entrant. Entries may not include clip art, copyrighted material, or any registered trademark or logo.

No Lettering. Do not include the Fair name, logo or theme name in the original artwork as it will be inserted in production.

All Inyo, Mono and Alpine County residents in grades 5-12 are eligible to enter. Students may submit an entry in each category. If the entrant is under 18 as of April 1, 2023, a parent or legal guardian must sign the entry form.

All entries must be submitted on **14” width x 17” height** paper. **(No newsprint)** Entries received on a different size paper or in the wrong orientation **(PLEASE NOTE: must be 14” wide x 17” high)** will be disqualified. Entrant’s name, address and phone number must be legibly written on the back of the poster.

Digital entries MUST include 14”x17” printed art as well as the digital image on a USB drive.

Entry deadline is Monday, April 3, 2023. Late entries will not be accepted. All entries must be accompanied by a signed official entry form.

Delivery of posters: Shipped entries must be sent to: Poster Contest, Tri-County Fair, 475 Sierra Street, Bishop, CA 93514. Mailed entries must be postmarked no later than April 3, 2023. Entries may be hand carried to the Tri-County Fair administration office: 475 Sierra Street, Bishop on weekdays between the hours of 8:30AM and 4:30PM.

A panel of 5 independent judges will select the winners.

Retention of ownership and rights: Tri-County Fair will retain ownership of and all rights to submitted artwork. Tri-County Fair may or may not use these posters in conjunction with the 2023 or subsequent Tri-County Fair promotional campaign(s).
